BRITISH ROWING 2024 OLYMPIC SELECTION POLICY & PROCESS

BACKGROUND

Selection to Team GB is a two-part process, involving British Rowing, as the National Governing Body for Rowing, and the British Olympic Association (BOA).

British Rowing and BOA set the minimum standard for selection. British Rowing publishes its selection Policy and Process (as set out in this document) which will determine any crews and individuals nominated for selection to the BOA. For the avoidance of doubt this document supersedes the British Rowing Selection Policy 2021-2024 for the purposes of selection to the events listed in 12.1 and the Paris 2024 Olympic Games.

The BOA will ratify the nominations by checking the agreed standard and other eligibility criteria have been met. The BOA will announce selections to Team GB.

The BOA makes the ultimate selection, however the BOA will only select crews nominated to it by British Rowing. Appeals or disputes concerning the selection of athletes for nomination by British Rowing to the BOA must be addressed to British Rowing, and it is British Rowing's rules and procedures that must be followed.

1.0 AIM OF PROCESS

- 1.1 The British Rowing 2024 Olympic Selection Policy & Process will assist British Rowing in determining the crews it wishes to nominate to the BOA for selection as rowing members of the 2024 British Olympic Team.
- 1.2 The aim of the process is to maximise the Gold medal winning potential of British crews at the 2024 Olympic Regatta and in turn of the broader British Olympic Team.
- 1.3 This process recognises the time taken to build successful Olympic crews and is designed to give continuity of development to crews or elements of crews where the relevant Olympic Selection Panel believe this will increase the probability of Gold medal delivery. It includes both the full 2024 Season and the results of the summer racing period of 2023 (Apr 2023 Sept 2023).

2.0 ELIGIBILITY

- 2.1 In order to be considered for selection an individual must fulfil the following minimum eligibility criteria:
 - 2.1.1 Be a British citizen
 - 2.1.2 Hold a valid passport and be able to travel to events and training camps
 - 2.1.3 Be eligible under the IOC/World Rowing Nationality Regulations
 - 2.1.4 Be eligible to compete under the IOC/World Rowing Gender Regulations
 - 2.1.5 Have a current British Rowing or Scottish Rowing racing membership
 - 2.1.6 Not be subject to any period of ineligibility or provisional suspension due to an anti-doping rule violation;
 - 2.1.7 Attend the National Training Centre or other venue notified by British Rowing when required;
 - 2.1.8 Complete, or be exempted from, each element making up the GBRT Olympic Selection Process
 - 2.1.9 Be available for any crew formation process or ad hoc trial notified by British Rowing;

- 2.1.10 Comply with any requirements or criteria communicated by British Rowing;
- 2.1.11 Fulfil any other eligibility rule or requirement from the IOC, BOA, WADA, World Rowing or any other relevant international or national governing body or organisation;
- 2.1.12 Sign a Team Member Agreement (TMA) when required by the BOA;
- 2.1.13 Be a fit and proper person to represent British Rowing and the BOA and not subject to any disciplinary or safeguarding investigations.
- 2.2 The Olympic Selection Panels may exclude from the process any crew or individual who cease for whatever reason to be eligible.

3.0 OLYMPIC SELECTION PANELS

3.1 The Olympic Selection Panels for Men and Women will be comprised of the following members:

- 3.2 In the event that a panel member is unable to fulfil their duties a suitable nominee may be appointed.
- 3.3 The 'External Selector' in their role alongside the Director of Performance, will:
 - 3.3.1 Ensure that the Olympic Selection Process is followed by the Head Coach
 - 3.3.2 Highlight any semblance of bias and provide the Head Coach with an opportunity to answer this with further evidence/explanation
 - 3.3.3 Actively contribute to the discussion so as to select the best crews
- 3.4 The selection decision for any other event(s) not listed in <a>12.1 will be made by the Head Coach(es) for the relevant event, as nominated by the Director of Performance.
- 3.5 A representative of the BOA will be invited to selection meetings where nominations are determined.

4.0 **SELECTION DECISIONS**

- 4.1 The factors that may be taken into account by the Olympic Selection Panels in making their selection decisions include the following:
 - 4.1.1 Results from crew formation races;
 - 4.1.2 Performance in the Selection Trial Process;
 - 4.1.3 Performance in ad hoc trials;
 - 4.1.4 National and International racing results in the current or previous seasons;
 - 4.1.5 Training performance including inter squad racing and trials;
 - 4.1.6 Ergometer results;
 - 4.1.7 Ability to maintain training loads;
 - 4.1.8 Making and maintenance of weight targets (lightweights and coxswains See <u>Appendix</u> <u>B</u>);
 - 4.1.9 Technical proficiency, level of skill and fitness;
 - 4.1.10 Any past, current or recurring injury or condition (physical or otherwise) which has or may have the potential to inhibit the performance of an athlete (or group of athletes);

- 4.1.11 Factors relevant to an athlete's combination within a crew, including but not limited to compatibility, personal attributes and attitudes, technical compatibility, crew balance and harmony;
- 4.1.12 Factors relevant to team balance and harmony;
- 4.1.13 Ability or willingness to train and compete within the British Rowing programme at times and places required or designated by British Rowing;
- 4.1.14 Findings from consultations with relevant coaches;
- 4.1.15 Findings from medical examinations, psychological evaluations or physiological analysis;
- 4.1.16 Potential for future development as an individual or combination; and
- 4.1.17 Any extenuating circumstances that may have impaired an athlete's performance or excluded an athlete from an event or trial.
- 4.2 British Rowing recognises the subjective nature of selection decisions and in making these, the Selection Panels, in their sole discretion and reflecting their expert opinion, may give what they consider to be appropriate weight to any one or more of the factors in 4.1.
- 4.3 In relation to the selection of coxes, the Selection Panels may take into account the factors at 4.1 as well as any performance relating to the competencies set out in Appendix C at C.7.
- In relation to the selection of reserve athletes for events, the Selection Panels shall take into account the needs of the team as a whole. This may mean, for example, picking a reserve who is able to sweep row and scull efficiently, rather than the next best sculler or rower. The role of the reserve rower is to support the training needs of the team. If a substitution is required at an event the needs of the racing crew will be prioritised and the next best available athletes will be selected. This will not necessarily be the named reserve.
- 4.5 For the Olympic Games, there may be up to 4 reserve athlete quota places. These are allocated to National Olympic Committees (NOCs) through the qualification of a Men's Quadruple Scull (M4x), a Women's Quadruple Scull (W4x), either a Men's Four (M4-) or Men's Eight (M8+), and either a Women's Four (W4-) or Women's Eight (W8+). Any accreditations for reserve athlete quota places will come with different entitlements to those of competing athletes.

5.0 SELECTION CRITERIA

- 5.1 To be nominated to the BOA, the relevant Olympic Selection Panel must be satisfied that the nominated crew has demonstrated their potential to finish in the A final (Top 6).
- 5.2 Where a boat class has been qualified but there is no crew capable of meeting the selection standard in <u>5.1</u>, in consultation with the BOA, a crew of future prospects with a trajectory for LA 2028 may be selected.
- 5.3 For the avoidance of doubt and notwithstanding any other provision in the process, the Olympic Selection Panels reserve the right not to nominate a crew for a particular event.

6.0 REGISTRATION & EXEMPTIONS

- 6.1 All individuals wishing to be included in the process shall register by 16 April 2023.
- 6.2 Late entries to the process may be accepted at the sole discretion of the relevant Olympic Selection Panel.

- 6.3 All individuals registering to enter the process will be required to complete the <u>online</u> registration and in doing so acknowledge that they understand and agree to the contents of this document.
- 6.4 If an athlete cannot participate in a trial or ergo test for a medical reason, the athlete must follow the correct procedure to apply for a medical exemption. A medical exemption request form (available from exemptions@britishrowing.org) must be submitted before the start time of the first race of the trial, or by 17:00 on the due date for submission of an ergo test result. Evidence in support of the exemption request should also be submitted. The request will be reviewed by the Chief Medical Officer or their nominee and must be approved by them in order for the athlete to remain in the selection process.
- 6.5 The Chief Medical Officer or their nominee may also approve a medical exemption request at a trial or other test without a form being submitted by the deadlines specified above, where they are in direct communication with the athlete on the day.
- An athlete will be expected to produce his or her best performance at all Selection Trials, other trials and races. If there is a medical reason why an athlete cannot perform at their best, the individual athlete will be required to submit a Medical Exemption Form, together with any relevant supporting documentation which must be approved. In the case of any other exemption request as to why an athlete or crew cannot perform at their best, the Director of Performance must be notified in writing in advance. The nature of the illness or injury or other reason will be established and monitored at an early stage by the Chief Medical Officer or their nominee, who will advise the relevant Head Coach and Director of Performance accordingly.
- While the Olympic Selection Panels may take account of any factor affecting performance, British Rowing is not bound to delay or alter the selection process as a consequence.

7.0 OLYMPIC SELECTION: SCHEDULE AND NOMINATION

- 7.1 The process starts on 14 April 2023.
- 7.2 The process will involve the following stages:

7.3 No nomination will be made to the BOA prior to May 2024.

8.0 STAGE 1 - 2023 SEASON SELECTION (APRIL 2023 - AUGUST 2023)

8.1 Crews will be formed for the 2023 World Rowing Championships in line with the Olympic Pathway Selection and Performance Strategy – 2023 World Championships.

9.0 STAGE 2 - 2023 WORLD ROWING CHAMPIONSHIPS (SEPTEMBER 2023)

9.1 Crews formed in Stage I will race at the 2023 World Rowing Championships, Belgrade, Serbia. This event is the first opportunity to qualify for the Paris 2024 Olympic Games. The number of quota places allocated at the World Rowing Championships for each boat class are:

- 9.2 Performances at the 2023 World Rowing Championships may shape the starting point for selection in 2024. (UPDATE: Where a quota place was successfully secured at the 2023 World Rowing Championships this has been designated with this symbol:

- 9.3 At the sole discretion of the relevant Olympic Selection Panel, individuals or crews may be exempted from elements of Stages 3 and 4 of the process where it is believed that this does not enhance their Olympic medal potential.

10.0 STAGE 3 - CONFIRMING LEADING CANDIDATES (OCTOBER 2023 - DECEMBER 2023)

- 10.1 Training for the 2024 Season will commence on Wednesday 4 October 2023. Registered individuals do not need to have been selected to the 2023 World Rowing Championships to be eligible for Stage 3.
- 10.2 The period from October 2023 to December 2023 is an opportunity for athletes to confirm themselves as:
 - 10.2.1 Leading candidates from 2023 Medal Zone crews to be retained as core members of these crews in the 2024 season.
 - 10.2.2 Leading candidates with the potential to challenge for a seat in, and to strengthen 2023 Medal Zone crews.
 - 10.2.3 Leading candidates with the potential to form new crews that could develop into Medal Zone crews.
- 10.3 The following Trials will take place during this stage of the process

- 10.4 The process for confirming the leading candidates for, and ultimately selecting, any available coxing roles is detailed in <u>Appendix C</u>.
- 10.5 The Head Coach may organise additional and compulsory assessments, test and trials with reasonable notice given.
- 10.6 Any individual that was not part of the 2023 World Rowing Championships Team will need to show significant potential to break into the team through the Open Trial on Saturday II and Sunday I2 November 2023.
- 10.7 Testing for invited candidates within the process will take place between 16 December and 23 December 2023. At the conclusion of this testing only athletes with the potential to make the 2024 Olympic Team as determined by the Olympic Selection Panels will be invited to take part in further crew formation.
- 10.8 Only in an exceptional case, and only where the athlete's inclusion could benefit the performance of the team, would a candidate be allowed to join the process after this stage. Any exception must be approved by the relevant Olympic Selection Panel and in writing.

11.0 STAGE 4 - CREW FORMATION (JANUARY 2024 - MARCH 2024)

11.1 By 31 January 2024 the Head Coach for each squad (Men's/Women's) will communicate the testing strategy for the formation of crews between 1 February 2024 and 25 March 2024. This communication will outline the dates and formats of any ergometer tests, selection trials and any periods of seat racing & crew formation.

12.0 STAGE 5 - OLYMPIC TEAM FORMATION (APRIL 2024 - JUNE 2024)

12.1 Crews may be selected for, and have the opportunity to demonstrate their performance standard at, the international events listed below. Crews may continue to be refined as necessary between races in light of international results, both with or without further crew formation testing.

- 12.2 In an exceptional case, a crew that is nominated to the BOA may race at World Cup III (Poznan, POL 14-16 June 2024) where this will benefit their Olympic preparations.
- 12.3 The number of quota places available at the Final Olympic Qualification Regatta for each boat class are outlined below. Where a quota place is qualified through the Final Olympic Qualification Regatta, the athletes that qualified the boat(s) at this event have to compete in the same event should they compete at the Olympic Games Paris 2024.

- 12.4 The Olympic Selection Panels retain the right to make unilateral changes to the shape of the team where results of international racing or internal testing indicate that changes to crews, no matter how successful they have been, could further maximise the Gold Medal potential of British crews.
- 12.5 The crews that are ultimately under consideration for nomination to the BOA must meet the selection criteria at 5.0.

13.0 STAGE 6 - NOMINATION TO THE BOA (MAYIJUNE 2024)

- 13.1 Olympic Selection Panels will be held following the completion of World Cup II after which crews will be nominated to the BOA.
- In nominating to the BOA, the Olympic Selection Panels will nominate the crews they believe will best represent Great Britain at the 2024 Olympic Games. Where this is in conflict with any part of the process outlined in this document, this principle shall take precedence.
- 13.3 The Director of Performance will work with the Head Coaches to allocate the coaching of crews and identify the staffing for the Olympic Games. The Director of Performance is ultimately responsible for the nomination of coaches and team officials to the BOA and will identify these individuals to best support the needs of the Olympic Team. The combined team of coaches and team officials will need to work within the allocated number of accreditations offered by the BOA.

14.0 CHANGES TO CREWS / DESELECTION

- 14.1 Following selection, an athlete may be de-selected by the relevant Olympic Selection Panel or British Rowing in the event of:
 - 14.1.1 The athlete ceasing to comply with the eligibility criteria set out in this Selection Policy
 - 14.1.2 Where the relevant Olympic Selection Panel, in consultation with the BOA, consider another athlete or selection decision is likely to lead to better results in accordance with the aim of this Policy.
- 14.2 In the event of there being a query over the ability of an individual to be able to compete to the best of his/her ability at an event due to an injury or illness, pre or post-selection but prior to the Delegation Registration Meeting, the following procedure will be followed:
 - 14.2.1 The British Rowing Chief Medical Officer ("CMO") can require an athlete to undergo a medical examination to determine his/her fitness to participate. This examination will be carried out by the CMO or another Doctor designated by the CMO. If it is the opinion of the nominated doctor that the athlete is not able to compete for medical reasons, he/she will be withdrawn from the event and if appropriate, a replacement will be selected in accordance with the Selection Policy.
 - 14.2.2 If the athlete passes the medical examination but the coaching and/or support staff still have concerns over whether or not the athlete is able to compete to the best of his/her ability due to the underlying injury or illness, the Director of Performance or Head Coach can require the athlete to undergo a set of sports specific performance tests where the results will be compared to the athlete's previous relevant results. The tests can be repeated more than once and within a short timeframe if required and will be carried out by designated support personnel. If as a result of the injury or illness the athlete does not meet the required test levels, he/she will be withdrawn

from the event on medical grounds and, if appropriate, a replacement will be selected in accordance with the Selection Policy. A BOA representative is entitled to be present for any or all of the tests comprising the assessment.

- 14.3 After the Delegation Registration Meeting with Paris 2024, crew changes may only be made by the BOA in consultation with the relevant Olympic Selection Panel in exceptional circumstances (such as injury or illness) in accordance with the IOC Late Athlete Replacement Policy.
- 14.4 In the event that a situation arises where the timing dictates that it is not possible for the relevant Olympic Selection Panel to meet, the decision will be taken by the Head Coach and Director of Performance, with the decision of the Head Coach being final in the event of any disagreement.

15.0 APPEALS

- 15.1 No legal action may be taken arising from a decision made by the Olympic Selection Panels.
- 15.2 Athletes should note that there are no additional rights to appeal relating to this Olympic Selection Policy. These remain as detailed in the British Rowing Appeals Procedure where an athlete only has the right to appeal against a decision of an Olympic Selection Panel where they believe that:
 - 15.2.1 there has been a failure to apply the applicable selection/nomination criteria; and/or
 - 15.2.2 there has been a failure to adhere to the procedure set out in the applicable selection/nomination Policy or Process.
- 15.3 Any appeals relating to this process and arising prior to 13 May 2024 will be conducted in accordance with the published British Rowing Appeals Procedure.
- 15.4 Any appeal lodged after 13 May 2024 will be subject to the amended timeframes and process outlined below.


If for any reason an appeal submitted prior to 13 May 2024 has not reached a conclusion by 26 May 2024, that appeal may become subject to these same timeframes.

16.0 AMENDMENTS TO THIS POLICY

- 16.1 In the event that an amendment to this Policy is required. The Director of Performance may make recommendations to the Board of British Rowing.
- 16.2 The Board of British Rowing may accept these recommended amendments and reissue an updated Policy at any time at its sole discretion.

APPENDIX B: WEIGHT MANAGEMENT AND CONTROL FOR LIGHTWEIGHTS & COXES

- B.I A cox must weigh a minimum of 40kg and in racing may carry up to 15kg of deadweight to meet the World Rowing requirement of 55kg. Only in an exceptional circumstance approved by the Director of Performance would a cox whose body weight was more than 55kg be selected.
- B.2 Body weights will be measured and recorded at trials and tests in line with 4.1.8. The weight requirements for lightweights and coxes between October 2023 and July 2024 are detailed below.

B.3 Lightweights and coxes will be expected to monitor their weight during training periods to demonstrate their health and ability to be safely in reach of testing weights.

APPENDIX C : SELECTION OF COXES

- C.I There may be up to 2 seats available for coxes of British boats at the Paris 2024 Olympic Games (M8+, W8+). In each case the gender of the cox will be open such that a male or female may cox a men's or women's boat in line with World Rowing Rule 21.
- C.2 Any cox who performs with distinction at the 2023 World Rowing Championships will be considered as a leading candidate for the boat in which they performed, for the 2024 Season.
- C.3 Any cox seeking selection who does not take part in the 2023 World Rowing Championships will be required to submit the following to gbrt.trials@britishrowing.org by 16 October 2023:
 - C.2.1 A coxing CV.
 - C.2.2 Two recordings of their coxing (each a maximum of 4mins one work/race outing, one technical) and a short written summary to give context to the technical and coxing focus at the time of each recording.
 - C.2.3 An indication of the seat for which they wish to trial (M8+ or W8+).
- C.4 Following the close of submissions only coxes with the potential to make the 2024 Olympic Team, as determined by the Olympic Selection Panels, will be invited to take part in further crew formation.
- C.5 By 31st January 2024 the Head Coach for each squad (Men's/Women's) will communicate the strategy for determining the nominated cox.
- C.6 Coxes may be observed and assessed during the process in the following settings:
 - C.6.1 Coxing coxing on the water in a training and racing or racing piece setting. This may be live or via a recording.
 - C.6.2 Coaching coaching on the towpath during a technical session to including the briefing, session coaching and debrief of a coxless crew.
 - C.6.3 Interaction day to day interaction with coaches, staff, and squad colleagues on land
